We also inform you that the processing carried out by the Municipality will be in automated and manual form, in compliance with the provisions of Article 32 of GDPR 2016/679 and Annex B of Legislative Decree 196/2003 (Articles 33-36 of the Code) on security measures, by specially authorized persons in compliance with the provisions of Article 29 GDPR 2016/679.
